Highlights of the year 2024 - 25

Health awareness program:

The **Arogya Project Phase - II** has made remarkable progress in delivering healthcare and awareness services across the community. Here are the key highlights of the year:

Primary Healthcare & Community Outreach

Rural Health Post (RHP):

- 3,851 patients received primary healthcare services through RHPs.
- 24 health camps were organized, benefiting 1185 patients with essential healthcare services.
- 688 HIV Screening through 24 Health Camps

• 2 Haat Bazar Health Services: 67 achieved

HIV/AIDS Awareness & Support:

- 912 beneficiaries received counseling services through ICTC and outreach programs.
- 1570 individuals gained HIV/AIDS awareness through 50 canopy camps.
- A One-Day HIV/AIDS Dissemination Workshop was attended by 92 participants from government and non-government organizations.
- 2,598 school students were sensitized through 35 school awareness programs.
- 1,360 youth were engaged through 120 Yuva Choupal sessions.
- 35 Zigyasa Peti installations were completed to enhance awareness.

TB Awareness & Support:

- 915 community members participated in 68 Para Baithak meetings.
- Support for 32 TB Patients received Nikshay kits, ensuring nutritional support during their treatment.
- Distribution of Nikshya Mitra kits with the support of BALCO employees
- 97 Capacity building of stakeholders MAS/VHSNC members
- Follow Up The reports of 22 TB patients have come back negative, and their health has also improved
- 22 TB patients have completed 6 rounds of distribution and 11 TB patients have completed 5 rounds.
- Wall Writing Slogan Completed
- Awareness messages were displayed through wall writings in 45 areas, educating communities about Tuberculosis Prevention and Treatment.

De-Addiction Initiatives:

- 699 villagers participated in one de-addiction awareness activity.
- 247 villagers engaged in 20 committee meetings on de-addiction.
- 467 school students were educated through 05 school awareness programs.

Maternal and Child Health & Nutrition (MCHN):

- 3374 Health screening of SAM/MAM Children 0 to 06 years age.
- 412 malnourished children received intervention through 26 PD Hearth (PDH) sessions.
- 26 post-PDH sessions were conducted, engaging 455 parents.
- 782 mothers participated in 45 Take Home Ration (THR) sessions.
- 721 pregnant and lactating mothers attended the "Nava Pahuna Goath" session.
- 11 child was referred to the Nutritional Rehabilitation Center (NRC).
- 385 mothers were sensitized through 32 Village/Urban Health and Nutrition Days (VHND/UHND) activities.
- 782 Home visits were conducted to address malnutrition among children

Anemia Control Program:

- A total of 2,231 mothers underwent anemia screening
- 648 mothers attended 45 two-day group sessions on anemia prevention and management.
- 778 post-HB screenings were conducted for monitoring and follow-up.
- 3,000+ Mothers were made aware of Anemia, its risks, and preventive measures to improve their health.

These initiatives have significantly contributed to improving community health and well-being across the intervention areas.

Community Engagement

- Special Day Celebrations: A total of 1,670 events were organized, including observances of World Tobacco Day in May and June.
- Election Awareness Campaign: Engaged 127 community members to promote informed voting and civic participation.
- Suposhan Choupal: Reached 23 people, focusing on nutrition awareness and community well-being.

Support on Pulse Polio Abhiyan

 Pulse Polio Booth with close coordination of Government Health department were implemented in 5 places Niharika, Ghantaghar, CSEB, ITI and Darri Bazar KORBA District of C.G.

Child and women rights and protection-

- More than 3374 + 2412 = 5784 children Screened for identification of Malnutrition.
- 36 PD Hearth (26 in Arogya and 10 in Nandghar Project) session for Wellbeing of children covering 527 (412 in Arogya and 115 in Nandghar project) severe acute malnourished and medium acute malnourished children were conducted.
- During the Year 2024 25 a Total of 31 CNCP (Child in need care and protection) children got support from Children Home.
- During the year total 9 children admitted and 10 children restored with their family with proper counselling and Guidance.
- A Total of 178 Children out of 203 till date Restored with proper education, counselling and training.
- 12 Children from Child home got Skill training and placed for employment.
- Total 7560 cases from child helpline number 1098 were handled during November 2013 to August 2024.

Women Empowerment -

- Under the NGSL CSR program 40 Goat was distributed to 20 Pashu Sakhis for their livelihood. 10 Stiching machines were also distributed to the Women group for livelihood of the women.
- Under the Watershed development program of NABARD nurtured and handholding support to the 35 Self-help groups.
- SROUT has formed more than 1000 Self help group from the inception of the organization.
- More than 1000 women got training of skill development and associated with the livelihood activities.
- Two SHG's (self-help groups) were provided with tent material for the work of tent house
- Two SHG's (self-help groups) were provided with Rice mill for the work of Paddy processing.
- Two SHG were provided boutique shop.

- Two SHG were provided grocery material for open a grocery shop for the livelihood support of women.
- 30 Women provided Petticoat Stitching training and linked them for stitching to the garment industry.

Soil and Water Conservation (Watershed)

- Main Phase of Songudha watershed started. Total around 1000 hactare land will treat for soil and water conservation.
- More than 1400 Hectare land was treated in our previous project Parsakhola watershed project.
- More than 800 Families benefitted from the Parsakhola watershed program.
- In the year 2023- 24 around 300 beneficiaries benefitted with different activities of Soil and Water conservation and climate proofing activities.
- SRI, Organic Farming, DRIP Irrigation, Farm Pond, Paddy Bunding, Contour Bunding has been made in Aurakachar, Songudha, and Dondaro Village of Korba district.

Sanitation and cleanliness -

- Awareness program on Sanitation was conducted with the help and support of PHED
 (Public Health and engineering department) Janjgir Champa district of Chhattisgarh
 state. Total 81 Panchayat and 109 villages covered.
- Awareness program on Sanitation was conducted with the help and support of PHED
 (Public Health and engineering department) KORBA district of Chhattisgarh state.
 Total 35 Panchayat and 49 villages covered.

Farmers Producers organization -

- More than 500 Farmers associated with the Nav kisaan farmer's producer's organization nurtured by the organization. This year more than 800 Farmers benefitted from the FPO Activities.
- Farmers producer's organization input shop is shifted to the new building constructed by the Balco CSR for FPO.
- The Input shop of Farmers producer's organization is continued in operation.

Drug De - Addiction -

• Under the **Arogya Health Project**, drug de-addiction activities have been successfully implemented, reaching approximately **20 villages and slums**. These initiatives aim to create awareness, provide support, and promote healthier lifestyles among vulnerable communities affected by addiction

Animal Welfare activities -

- This year in 2024 25 social Revival group of Urban Rural and Tribal has been engaged in animal welfare program and more than 200 Dog vaccinated for Rabies.
- Rabies Awareness program was organized and community will be benefitted for awareness program.
- 1500 cow belted with reflective belts.

Drinking Water -

- Awareness program on Drinking water was conducted with the help and support of PHED (Public Health and engineering department) Shakti District of Chhattisgarh state. Total 81 Panchayat and 109 villages covered.
- Awareness program on Drinking water was conducted with the help and support of PHED (Public Health and engineering department) KORBA district of Chhattisgarh state. Total 35 Panchayat and 49 villages covered.

Project Details



Arogya project –. Project Arogya is a health project on health implemented by SROUT in support of Balco CSR. Year 2024 – 25 was the First year of the three years program of Arogya Phase II. The project aims to target areas of issues in health care and supports the community with interventions in Primary Health Care, Awareness on various seasonal and non-seasonal diseases. Specific emphasis is laid on Malaria, TB, HIV and Maternal & Child Health in order to create a community which is free from diseases and can lead healthy and prosperous lives.

The program has been implemented in Balco's plant location, actively covering 45 core villages & Urban slums covering over 35000 people. The introduction of Arogya in these areas in relevant as most of the villagers had to travel a great distance to avail medical facilities, also the medical facilities used to cost a significant amount which is more than what

rural population could afford. After the introduction of Rural Health Posts the health care services have become both accessible and affordable.

Child home boys_— Under Mission Vatsalya formally called integrated child protection scheme of Ministry of Women and Child development department, Balgrih boys is being implemented at Korba District. There were 31 children live in this year 2024 -25. The Child Home for Boys is a shelter for male children who are in need of care and protection. This may include children without parental care, runaway children, migrant children, and child substance abusers. Started in 2013, it has the capacity for up to 50 children, providing accommodation, basic, care, as well as counseling and support as needed. The home works closely with the local Child Welfare Committee to respond to each unique case, determining the best and most caring option for the child, with an ideal of reintegrating the child with their family if is possible and reasonable. From beginning of the project, a total of 178 Children out of 203 till date Restored with proper education, counselling and training. 12 Children from Child home got Skill training and placed for employment.

Shakti Sadan: Under mission Shakti of Ministry of Women and Child Development the Shakti sadan formally called ujjwala grih was operationalized in Korba District of Chhattisgarh. 15 women and two children got shelter support In year 2024 – 25, Since



their inception in 2013 Total 239 Women got shelter and total 230 women restored with their family. The Shakti Sadan objective is to provide shelter to the needy women and girls who are abandoned by the family or a victim of any type of harassment, Domestic Violence etc.

Farmers producer organization

The Farmer Producer Organization (FPO) is an initiative to assist small and marginal farmers in accessing inputs, investments, technology, and markets by mobilizing them to leverage their market aggregate market power. Through collective action, farmers are able to enhance productivity through efficient, cost-effective and sustainable resource use. They attain a higher market value for their produce by controlling a larger market share. The combination of these two factors leads to significantly higher returns for their labor and production. SROUT supports an FPO in Bhatgaon village of Korba district. Farmers producer's organization input shop is shifted to the new building constructed by the Balco CSR for FPO. The Input shop of Farmers producer's organization was inaugurated by the Head Balco CSR Ms. Monika Jain. The new input shop is being operated this year also. Major Activities is to aware farmers for the new techniques of Farming practices, Adding New members.



Livelihood Programs

NGSL CSR Support us for training of 30 women for livelihood 20 for goat rearing and 10 for stiching program.

SROUT has operating self-sustained livelihood initiative of stitching for women of SHG's and girls for Petticoat Stitching so that they can become self-reliance in terms of livelihood generation. They got training and engaged in petticoat stitching activities placed for

livelihood at nearby garment industry. SHG members also supported from Watershed development programs.

Watershed project -



Agriculture is a primary income source for approximately 80% of Chhattisgarh's inhabitants. The majority of these farmers rely on rainfall and traditional methods to cultivate their produce. As a result, agricultural communities are highly vulnerable to

unpredictable weather patterns, such as flooding and drought. The Watershed Development Program is designed to improve soil quality and water conservation through earthen structures that slow down the movement of rainwater through an area as well as water storage strategies that provide irrigation sources for dry months. Though facilitated by SROUT staff and funded by NABARD, this is a village-led program, with community members making decisions and providing labour to implement water management strategies.

Currently, SROUT is supporting a watershed development project in the Songudha watershed, encompassing the Songudha, Aurakachar, and Dondaro villages. April 2022 is a month to start main phase of songudha watershed project. From April 2022 Project Activities has been started and Farm Pond, Paddy Bund, Contour Bund, Plantation, DRIP Irrigation system installation, organic farming, SRI and Many Self-help group income generation activities been started in year 2024 – 25.

Jal Jeevan Mission – SROUT is implementing Jal Jeevan mission program at Shakti and Korba district. In Jangir Champa 109 village and 81 panchayat is being covered and in korba district 35 panchayat and 49 village is being covered under the program.





Animal Welfare activities –

- This year in 2024 25 social Revival group of Urban Rural and Tribal has been engaged in animal welfare program and more than 200 Dog vaccinated for Rabies.
- Rabies Awareness program was organized and community will be benefitted for awareness program.
- 1500 Cows was belting reflective belt for reducing the road accident.

Support on Pulse Polio Immunization Program- Immunization camps were organized at 5 places of Korba which includes Niharika chowk, ITI Chowk, Ghantaghar Chowk, Transport Nagar Chowk, Darri Bazar and more than 300 children given pulse polio vaccine through our posts.

Awareness Programs on National Days – National womens day, World AIDS day, Environment day, Immunization day, Malnutrition week, Menstrual hygine day etc were commemorated aiming awareness to the community.
